Shareholders at PowerGen, a major power company in Great Britain, have approved the proposed acquisition of LG&E Energy Corp., headquartered in Louisville.

The Kentucky Public Service Commission approved the deal last month and completion of the acquisition rests with LG&E's shareholders and other regulatory agencies.

According to company information, LG&E is a leading supplier of gas and electricity to large industrial customers. It has 1.1 million domestic customers and operates power generation plants in six states.

PowerGen is one of the world's major independent power businesses and one of the UK's leading integrated electricity and gas companies. It is also an international power generation business involved in 11 projects totaling more than 8,000 MW in Germany, Portugal, Hungary, India, Indonesia, Thailand, South Korea and Australia.

IGC Balanced Payment Plan customers may see increase

Indiana Gas customers on the Balanced Payment Plan program will receive settle up statements in their upcoming July bills. Customers on the program are likely to see an increase because IGC has recalculated the plan to reflect consumption during a normal winter season and natural gas prices have risen since the prior amounts were calculated. A bill insert will be included to help explain the available options to the approximately 96,000 customers using the plan.

Indiana Gas helped sponsor the Region IV 14th Annual Senior Games.


More than 600 seniors in Tippecanoe and surrounding counties participated in the June 12-16 event.
